In accordance with that authority, I hereby move to adopt a rule allowing members of the Commission to participate and vote virtually where a quorum of the Commission is physically present in a location of the hearing. Adoption of an amendment for the unified bipartisan bipartisan redistricting plan. Leader Russo has a motion regarding an amendment to the unified bipartisan redistricting plan that was unanimously passed on Tuesday. Leader Russo, Would you please explain your motion?

**House Minority Leader Allison Russo** [00:01:57] Mr. Chair, I move to amend the General Assembly plan that was adopted by this Commission on Tuesday, September 26, 2023. The amendment relates specifically to boundary modifications involving only Ward 34 Precinct C in Franklin County. Under the adopted plan, Franklin County's Ward 34 Precinct C was inadvertently drawn within the Fifth House District and Third Senate District. The proposed modifications, which reflect the Commission's original intent with Tuesday's adoption of the plan, draw Ward 34 Precinct C, wholly within House District 2 and Senate District 15. Except for these specified boundary modification, the plan remains unchanged from the version adopted by the Commission on Tuesday.

**Co-Chair Auditor of State Keith Faber** [00:02:53] Is there a second for Leader Russo's motion?

It just makes a minor tweak, a technical change to correct it, just a boundary issue. And by the way, for a little history, we heard from Ray DiRossi, our resident redistricting historian, that the similar process had to occur in each one of the decade - wasn't redistricting - apportionment board meetings in the past with a technical adjustment. And this is why we mentioned on Tuesday's meeting we may have to come back for technical changes with that. Any other discussion or details on the amendment? No? Leader Russo.
