Subject: Testimony for Cleveland Area Commission Meeting 9/13

Greetings and Good Afternoon --- To Chairperson and respective Commision members.

I currently serve the people of Messiah Lutheran Church of Fairview Park, Ohio (a first ring suburb of Cleveland's westside, I currently reside in beautiful North Olmsted, Ohio yet, I hail from the zip code of 44691 - Wooster, Ohio, I attended college in Springfield, Ohio the county seat of Clark County, I served in Americorps for 10 months in the Linden Neighborhood of Columbus, my wife and I purchased our first home in Green Twp in the Western Hills outside of Cincinnati, and she and I resided in the 43209 zip code of Bexley, Ohio for several years duringand after graduate school studies.

All of this speaks to great privilege. I am before you with a clear message..... Listen to the people. I implore each of you --- and by extension the entire Legislative and Executive elected leadership -- to devest yourselves and LISTEN to the people you are hearing from in this process. Listen to the citizens of your home districts -- Yes --- and listen to the citizens -- the people.

I happened to click past the Public Access Channel --- Ideastream --- and I happen to catch portions of your Commission Meeting from the Dayton area. The African American Realtor Mom who brought her recent high school graduate daughter...... Listen to her! And listen to countless others who you have and are hearing from.

This process is critically important. And the current map does not do justice to the people --- All people --- of our great state.

Let me conclude with this --- I realize this redistricting will not satisfy all the people. This redistricting can be 100 % just, however, we all must do better, and it included you --- the honorable members of this Commission -- Listening, and then Acting.
